

General Databases for Evidence-Based Programs

This list is not exhaustive, however it is an excellent starting point for finding existing evidence based programs to implement. Using an evidence-based program in grant writing offers several key benefits that can significantly enhance the likelihood of securing funding. These benefits include:

1. Increased Credibility

• Evidence-based programs are backed by research and data, demonstrating that they have been rigorously tested and proven effective. This credibility can make your grant proposal more convincing to funders, as it shows that the program is not just a theoretical idea but one that has yielded positive results in similar contexts.

2. Demonstrated Effectiveness

It shows that your organization is committed to using the best available practices to address the problem at hand, giving your proposal an edge over others that may rely on untested or less proven approaches.

9. Supports Sustainability

• Programs that are evidence-based often have established models for sustainability, ensuring that the benefits of the program can be maintained over the long term. Funders are more likely to support programs that have a clear plan for ongoing impact beyond the initial funding period.

10. Builds Trust with Stakeholders

• Using an evidence-based program can build trust not only with funders but also with other stakeholders, including community members, partners, and participants. It demonstrates that your organization is committed to using proven strategies to achieve positive outcomes, which can strengthen partnerships and community support.

1. What Works Clearinghouse (WWC)

Focus: Education

- Provides evidence-based evaluations of educational programs, practices, and policies. WWC reviews existing research to determine what works in education, offering a wide range of programs that have been rigorously evaluated.
